## **DISCUSSION:**

• Chairman William W. Bain Jr. and Commissioner Frank Smith commend everyone for all their efforts.

# **<u>BEXECUTIVE DIRECTOR REPORT:</u>**

- E.D. Gober indicates HAGC has had 65 interim recertifications resulting from the COVID pandemic and believes HAGC may encounter an issue with inspections, HAGC at this time has 500 inspections waiting to be completed due to the pandemic. HUD is allowing live video inspections and will be releasing guidelines for them once more information is received it will be shared with the Board. HAGC has accepted the waiver for late inspections. HUD may possibly waive the back logged inspections, we wait for word from HUD, but this may not be conducive for inspections needing to take place at HAGC owned and managed properties, as to be sure of the upkeep of HAGC properties.
- E.D Gober indicates that there are two employees on leave due to COVID, two employees working from home or combination of office and home. The four temporary staff members hired to assist in essential functions involving caring for the residents needs in our congregate program, which provides meals, housekeeping, shopping and laundry services to our residents, will be extended through June.
- E.D Gober indicates HAGC will continue to perform only essential work orders at this time. There seems to be a decrease in work orders being reported, which may be due to the pandemic, that may lead to staffing issues once starting to take all work orders again. AHO Director Paul Letizia indicates we are continuing to bring in staff on the weekends for sanitation purposes.
- E.D Gober indicates two resolutions form the Pre Board Day Packet have been removed, one resolution for the Congregate Program, the grant process moves quickly once the State issues the information and HAGC wanted to be ready, but at this time the State has not issued the needed information. The second Resolution removed was the MOU with Gloucester County, HAGC and Rowan College of South Jersey involving the predevelopment expenses where the County is fronting the upfront expenses for the three acres RCSJ set aside for the 24 Special Needs units, where the individuals will have onsite resources and programs available to them. The MOU has been reviewed by HAGC counsel and the County's counsel, the language is not finalized, but is anticipated to be on June's agenda.
