# **TEXECUTIVE DIRECTOR REPORT:**

• E.D. Gober indicates the Rowan College of South Jersey Project is progressing, NJ Department of Community Affairs has some question regarding the previously submitted funding application, and we continue to be responsive. On September 9<sup>th</sup> plans were presented to the Deptford Township Development Review Committee, positive feedback was received from the

- committee. On November 3<sup>rd</sup> the plan is to make application to the Deptford Township Planning Board for preliminary and final approvals. The project is progressing.
- E.D. Gober indicates that Shepherds Farm's roof replacement is in progress.
- E.D. Gober indicates GHA had closing in August with Pennrose for the 24 RAD units and with the NJHMFA for the tax credit property. August 4<sup>th</sup> site work had begun and continues.
- E.D. Gober indicates HAGC is working with the County providing closed clinics for Flu shots, which are scheduled at all of our buildings, as well as the COVID booster shot for the employees and residents of HAGC.
- E.D. Gober indicates at the beginning of the month Hurricane Ida touched ground in our area, considering some of the devastation seen throughout the County HAGC was fortunate in the amount of damage sustained. HAGC will be making a claim to our insurance company and a FEMA application. A full report will be suppled to Commissioners next month.
