### **EXECUTIVE DIRECTOR REPORT:**

- E.D. Gober indicates Congress was supposed to be passing a continuing resolution to fund the government through December 20, 2024, and was not certain if it passed. One of the things all the industry groups are advocating is to have a budget before the end of the year. PHADA published a position paper that details HUDS budget and we will be keeping an eye on that.
- E.D. Gober mentions there are some updated Policies in the Agency Plan. The five-year and Annual Plan must be submitted to HUD in October. Jeff Daniels, Esq., spent lots of time on the eight components of the Agency Plan, met with the Resident Advisory Board and incorporated the comments into the plan. There was a Public Hearing yesterday, no members of the public attended.
- E.D. Gober discusses changes to the Section 8 Administrative Plan and Grievance Policy.
- E.D. Gober discusses a study called "The State of the Nation's Housing 2024" by JCHS of Harvard University. The report states that rent continues to rise, and the cost burden has reached an all-time high. This relates to the cost of the Voucher Program, because it is beyond what the government can fund. Based on this study the most burdened group is the middle class rather than the lowest class.
- E.D. Gober mentions that Congressman Jeff Van Drew will be visiting HAGC's properties on Monday.
- E.D. Gober mentions the construction of the administrative offices is underway and making progress.
- E.D. Gober indicates that Rowan College of South Jersey reports that a 1.6 million dollar draw request has been made to the state to reimburse construction expenses and funds were received this month.
